Metsimaholo Local Municipality seeks to appoint suitably qualified candidates to serve as members of its audit and performance committee in order to comply with the provisions of the section 166 of the Municipal Finance Management Act.

Requirements: Relevant degree or equivalent qualification in Accounting, Financial Management or Auditing, Certified Internal Auditor (CIA) or CA (SA) and experienced Internal Auditors functioning at senior level will have preference. Minimum of 5 years experience in Audit and Risk Management across the business environment. Knowledge and experience in Municipal Performance Management System. Understanding of major accounting practices and public sector reporting formats (GRAAP), Legal experience and Strong consulting and advisory skills, thorough understanding of Corporate Governance Principles.

Duties: Provide advisory services to the Council in terms of the Municipal Finance Management Act (MFMA) section 166. Review the adequacy and effectiveness of internal controls. Examine and review the annual financial statements. Review compliance with all regulatory requirements. Review the Performance Management System. Advise council on development and/or issues of performance management policy etc.

The term of office will be a three year contractual term. The successful applicant will be remunerated for attendance of meetings according to the tariff determined by Council. No remuneration for participating in committee meetings will be payable to officials employed at national, provincial and local government, its agencies or other entities regarded as falling within the definition of an organ of state, except for out of pocket expenses which may be reimbursed.
