GENERAL ASSESSMENT RATES AND TARIFFS: 2024/2025 FINANCIAL YEAR

1. Notice is hereby given in terms of **Section 17(3)(a)(ii) and 24(1)(2) of the Municipal Finance Management Act 2003 and section 14(1) and (2) of the Local Government: Municipal Property Rates Act 2004** that the Municipal Estimates of Revenue and Expenditure for the 2024/2025 financial year has been approved by Council on 31 May 2024, of which a copy is available for inspection at the Office of the Chief Financial Officer during office hours of the Council
2. Notice is also hereby given that:
 - I. The general assessment rates for the financial year ending 30 June 2025 has been assessed in accordance with the provisions of section 24(2)(c) of the Act:

	Actual 2023/2024	Approved 2024/2025
Industries	0.032142	0.033717
Businesses	0.021147	0.022183
Residential	0.010714	0.011239
Agricultural	0.002641	0.002770

3. The aforementioned rates are recoverable by the Council in terms of the provisions of the Act and payable in equal monthly instalments except for agricultural land and state property. **In terms of Section 24(2)(c) of the Act and section 64(2) of the Municipal Finance Management Act 2003**, interest is payable on all rates in arrears
4. **Tariff increase:**
 - Water Tariffs = 4.9%
 - Waste Management = 4.9%
 - Waste Water Management = 4.9%
 - Electricity = 12.7% (Subject to approval from NERSA)
 - Sundry Tariffs = 4.9%
